

An Open Letter to the President and our Legislators

We, the former senior government officials and crossover leaders of the International Center for Innovation, Transformation, and Excellence in Governance (INCITEGov), write to express our profound concerns regarding the proposed 2025 General Appropriations Act (GAA).

While we commend President Ferdinand Marcos Jr.'s good intentions for the 2025 GAA, we are deeply troubled by the gross misallocations in the final version of the budget as approved by Congress. We are concerned that line-item vetos will not be enough to rectify the problematic priorities embedded in next year's budget.

We therefore urgently appeal to President Marcos and our legislators to revamp the proposed budget and restore the funds that have been unjustly removed from vital sectors such as health, education, agriculture, social protection, transportation, and climate change adaptability. These services are indispensable for taking care of the welfare of our most vulnerable citizens and ensuring the well-being of our nation. Allocating sufficient resources to these sectors is not only a moral obligation but also a strategic imperative for achieving long-term economic growth, stability, and sustainability.

Furthermore, we call for a meticulous examination of the unprogrammed appropriations and the elimination of pork barrel items from the proposed budget. Several key big-ticket infrastructure projects, including those listed in Build Better More, are inexplicably found in the unprogrammed appropriations, and this will lead to undue delays in the construction and completion of such projects—to the detriment of Filipinos.

By contrast, the substantial allocations for several infrastructure items (specifically in the Department of Public Works and Highways) are unmistakably pork barrel in nature, prioritized at the expense of critical essential services, and are particularly alarming. Wanton pork barrel spending leads to the misallocation of resources, inefficiency, and wastage of public funds absent inadequate oversight and planning. It fosters corruption and political favoritism, undermining public trust and resulting in unbalanced development.

We are also gravely concerned that the process of crafting the current proposed 2025 national budget appears to have violated constitutional principles. The bicameral conference committee's decisions on budget insertions and allocations were made opaquely and with no checks and balance, bypassing the oversight and accountability essential for such a significant piece of legislation. Furthermore, the 2025 budget clearly violates the constitution's mandate to allocate the lion's share of the budget to education.

The national budget is the clearest reflection of a government's priorities. **We echo the calls** from various sectors to align the national budget with the administration's 8-Point Socioeconomic Agenda and the Philippine Development Plan (PDP) 2023-2028,



encompassing food security, healthcare, education, job creation, poverty reduction, affordable and clean energy, and infrastructure development.

We comprehend the complexities and challenges of crafting the annual budget of the national government. Nonetheless, we firmly believe that prioritizing the welfare of our citizens and upholding the integrity of our budgetary process are essential and nonnegotiable.
